5. Details of a conviction for an offence under the above mentioned provisions must be given if the applicant was convicted of the offence or if the person convicted of the offence ("the relevant person"):-
  - (a) committed it in the course of his/her employment by the applicant;
  - (b) committed it in the course of the carrying on of any business by a partnership, one of the members of which was the applicant;
  - (c) was a body corporate and at the time when the offence was committed the applicant was a

director, manager, secretary or other similar officer of that body;

- (d) was a director, manager, secretary or other similar officer of the applicant (where the applicant is a body corporate);
- (e) was a body corporate and at the time when the offence was committed a director, manager, secretary or other similar officer of the applicant held such an office in the body corporate which committed the offence.

Under the Waste and Contaminated Land (NI) Order 1997, any person who is not a registered carrier of controlled waste, and who in the course of any business or otherwise with a view to profit, transports controlled waste to or from any place in Northern Ireland shall be guilty of an offence which carries a fine of up to £5,000.
